MINUTES OF GENERAL MEETING RPEA Chapter 040, June 14, 2017

Members enjoyed lunch beginning at 11:00 am before the meeting began, at the HomeTown Buffet in Santa Ana, compliments of Ch 040.

The regular quarterly meeting of RPEA Chapter 040 was called to order by President Ivory Webb at 12:00 pm. Treasurer John Jago led the members in pledging allegiance to the flag of the United States of America. Inspiration and Sunshine Chair Evelyn Hicks played a recording of "Ragged Old Flag" by Johnny Cash in honor of flag day. It was good to see Frank and Evelyn at the meeting.

Several new members introduced themselves, and President Webb introduced Area VIII Director Kathleen Collins.

Minutes: The minutes of the general meeting of March 8, 2017, and the board meeting of April 12, 2017, were read by Secretary Mercedes Smith. Viola Sadler moved to accept the general meeting minutes as read. MSP. Evelyn Hicks moved to accept the board meeting minutes as read. MSP.

Treasurer's Report: Treasurer John Jago reported the ending balance in the checking account and there were 521 paid members as of May 31, 2017. A copy of the report is attached. Jerry O'Keefe moved to accept the report as read. MSP The biggest expense is the printing of the newsletter and the postage to mail it. Viola Sadler has not had many members provide their e-mail addresses so that money could be saved by e-mailing the newsletter.

Membership: Bill Todd concurred that the actual paid membership number is 521, but at this time there are 2 unpaid members for a total of 523.

Guest Speaker: Viola Sadler introduced Neeta Merchant from the Orange County Council on Aging who spoke on the Health Insurance Counseling and Advocacy Program (HICAP). She provided a handout on some of the services that HICAP has including free, unbiased counseling either by phone or in person for one on one sessions. Also available are

wellness and preventive services, advance care planning, and the right to appeal billings or denial of services. A brochure on Medicare was also provided and HICAP will help with any possible Medicare fraud and answer questions during open enrollment in October through December. Ms. Merchant advised that one can become a volunteer as a counselor after State training if anyone is interested.

New Business: Area VIII Director Kathleen Collins provided information on RPEA Legislative Tracking and Position for 2017-2018 State and Federal Legislation and there was some discussion on the issues.

She advised that J.J. Jelincic is no longer running for a seat on the CalPERS board. Michael Flaherman is running for Position A and is endorsed by RPEA. No RPEA endorsement has been made for Position B, however, Chapter 040 member Wisam (Sam) Altowaiji is running for that position.

Kathleen reminded us that the 2018 General Assembly will be held in Anaheim and that Chapter 040 should begin thinking about programs and/or entertainment for the event.

Old Business: Jerry and Jeri O'Keefe brought a plaque to be presented to the family of Bill Donoghue. Unfortunately, no one from the family was able to attend this meeting. The O'Keefes will make arrangements to get the plaque to the Donoghues.

Viola Sadler provided copies of the Chapter 040 by-laws which were updated in July 2016 after decisions were made on changes at the General Assembly held in July 2016.
