**TOPIC: “Are you prepared for the next disaster in Butte County?”**

That includes having a plan for evacuation, shelter-in-place, and communications. This presentation will include a video, and it is an important topic for all of us.

### HEALTH BENEFITS REPORT – By Al Raitt

During the December, 2017 Stakeholders meeting at CalPERS Headquarters, staff reported on Prescription Drugs Utilization and Cost Trends. They provided some interesting data. Data is updated every month, and analyses of claims data demonstrates costs for drugs covered under Pharmacy Benefits and Medical Benefits continue to rise. For example, the 2016 total drug costs (includes prescription and over-the-counter meds) paid under Pharmacy Benefits for all California Public Employees’ Retirement System (CalPERS) plan were \$2.153 billion including \$857.46 million for Medicare. Specialty drugs (used for special conditions such as cancer, cystic fibrosis, HIV, Psoriasis, Crohn’s disease, and others) often require special “handling” such as refrigeration and given by injection or intravenous infusion. They are not carried in a typical pharmacy and have to be ordered from a “specialty pharmacy” and usually expensive. A percentage of the total prescription drug cost was 28.05% (\$240.53 million) for Medicare even though specialty drug prescriptions represented only one percent of all prescriptions. Specialty prescription drug cost trends from 2012 to 2016 demonstrated a sharp increase from \$185.76 million to \$408.43 million. The top ten specialty drugs accounted for \$218.02 million spending or 53.40% of the total specialty drug cost. CalPERS staff continues to explore options for controlling expenditures on prescription drugs covered under Pharmacy and Medical Benefits while maintaining healthcare quality, choice and affordability.

A point made several time by staff is that CalPERS has tried over the years to keep copay costs as low as possible. However, reading between the lines, it’s quite possible that copay costs, as one of the “explored options,” will be vulnerable to increases over the next few years. It’s probably prudent for us to begin holding on to our collective wallets as we monitor what our copays are over the next few years!
