Legislative committee year end meeting

Some of the bills we supported were signed into law, some vetoed, and some live on for one more year.

We were disappointed in the veto of our sponsored bill (AB 469 California Public Records Act Ombudsperson) which would have created an ombudsperson to investigate agencies who thwart existing laws forcing one to go to court.

In his veto message the governor cited the bill was

unneeded, redundant and cost money the state doesn't have.

Hi Everyone,

I can't believe that we are in the midst of Fall already. We are starting to look forward to holidays, friendship, and good food. It is funny how our stomachs always seem to come into play during the Holiday Seasons. We will be having our




Thanksgiving Feast at Cracchiolos on November 9, 2023. I'm really looking forward to seeing you all there. As has been our habit, we ask attendees of this meeting to bring an item for someone less fortunate as a donation. This year we have chosen to support the Personal Care Pantry (PCP) at United Methodist Church on North Street in Woodland.

In case it has slipped your mind, let me remind you about this program and the good it does in our communities. The Personal Care Pantry provides things that most Food Banks do not carry. It provides items such as shampoos, laundry soap, toilet paper, deodorant, tooth brushes and tooth paste, diapers, adult hygiene products, and items needed for women's personal hygiene. PCP receives no government grants and is operated solely on donations from church members, contributions and community grants from local community programs such as Rotary, Elks, etc. It does not advertise its services. People learn about the Personal Care Pantry through word of mouth. This program caters to what can be termed the "working poor", families who are working, but not earning enough to carry them through the month.

This last year has been extremely hard on low income families with inflation, steep increases in the price of most everything and the end of some of the subsidies associated with the pandemic. PCP has also faced those same price increases (even the Dollar Store increased prices on most things to \$1.25). Last year at this time, PCP was averaging 80 to 100 visitors per month with a total family estimation somewhere between 600-800. The average cost last year was \$600.00per month. This year, they are averaging between 150 and 180 visitors with a total family estimation of 700-900. The cost has jumped to \$1200 per month. These budgets do not include the pur-

chase of diapers or Adult Personal Hygiene products and those are the most expensive items they provide.

PCP has been fortunate to receive donations of these products, but they are now in desperate need of Adult Hygiene Products and feminine hygiene products. We ask that you keep that in mind for any donations you may choose to make. If you choose to make a check or cash donation, please remember to make out your checks to Woodland Methodist Church with a note on the check that it is for the Personal Care Pantry.


